

## Actief aandeelhouderschap

De missie van Klaverblad Verzekeringen is een belangrijke bijdrage te leveren aan het goed functioneren van de samenleving. Wij vinden het daarom belangrijk dat we middels onze beleggingen een positieve impact hebben op de reële economie en de maatschappij. We willen daar waar we kunnen onze invloed aanwenden door onze stem te laten horen om verandering in bedrijven en staten te behalen waarin we beleggen.

Via stemmen en engagement als instrumenten van actief aandeelhouderschap kan Klaverblad entiteiten stimuleren om te veranderen, zodat hun activiteiten meer bijdragen aan de impact die Klaverblad met haar beleggingen wil realiseren. Het beleid op actief aandeelhouderschap is te vinden op <u>Duurzaam</u> beleggingsbeleid Klaverblad | Klaverblad Verzekeringen.

Het uiteindelijke doel van actief aandeelhouderschap is om impact te creëren in de echte wereld. Klaverblad wil haar doelstellingen bereiken door ervoor te zorgen dat entiteiten gedragsverandering laten zien. Bovendien is Klaverblad ervan overtuigd dat entiteiten die hun gedrag veranderen als reactie op stem- en engagementinitiatieven van Klaverblad ook lagere ESG-risico's zullen hebben. Stem- en engagementinstrumenten vullen elkaar aan, waarbij stemmen uiteraard alleen mogelijk is bij bedrijven waarvan Klaverblad aandelen bezit.

Klaverblad is in het hele financiële spectrum een relatief kleine belegger waarbij onze invloed op het gedrag van bedrijven gering is. Wij laten echter wel onze stem horen over de doelen die wij hebben gesteld en willen bereiken. Voor ons is het belangrijk dat we onze krachten bundelen met andere partijen die een vergelijkbaar geluid willen laten horen.

Klaverblad doet mee aan stem- en engagementbeleid van de vermogensbeheerders en monitort actief of dit in lijn is met het Klaverblad-beleid. Als dit niet het geval is, dan gaan we hierover het gesprek aan met onze vermogensbeheerders. Daarnaast haken we actief aan bij gezamenlijke sector brede engagementinitiatieven, voor zover dit in lijn is met onze doelstellingen.

### Ad 1 Engament via Cardano

#### Klimaat

Klaverblad sluit zich aan bij collectieve engagementinitiatieven om effectief invloed uit te oefenen op de grootste uitstoters in haar portefeuilles. Klaverblad committeert zich hierbij aan het voeren van engagement met de 20 grootste uitstoters (bedrijven) in de portefeuille óf de bedrijven die gezamenlijk verantwoordelijk zijn voor 65% van de emissies.

### **Biodiversiteit**

Klaverblad sluit zich aan bij collectieve engagementinitiatieven om effectief invloed uit te oefenen op bedrijven die water onttrekken in gebieden met waterschaarste zodat zij beleid en strategieën formuleren om waterneutraal te worden, producenten en/of gebruikers van bestrijdingsmiddelen om terughoudendheid in het gebruik te stimuleren, bedrijven die actief zijn in regio's dichtbij kwetsbare ecosystemen of in gebieden die als hotspotgebieden voor biodiversiteit zijn aangemerkt, en overheden om regulering op gebied van biodiversiteit te versterken/introduceren.

### Ad 2 Engagement via VBDO

Onder regie van VBDO heeft een groep internationale investeerders een gezamenlijke verklaring afgelegd waarin zij bedrijven in de nikkelwaardeketen oproepen tot meer verantwoordelijkheid en transparantie. Klaverblad is hiervan medeondertekenaar. De focus ligt op:

- Milieu-impact van nikkelwinning, vooral in tropische gebieden
- Mensenrechtenrisico's, waaronder landrechten en arbeidsomstandigheden
- Verantwoord inkopen door bedrijven die nikkel gebruiken in batterijen en technologie
- Oproep tot due diligence, rapportage en samenwerking met lokale gemeenschappen

De verklaring benadrukt dat investeerders duurzame nikkelproductie als essentieel beschouwen voor de energietransitie, maar dat dit niet ten koste mag gaan van mens en milieu. Voor Klaverblad betreft het de volgende bedrijven:
